Special Information for the Spring 2021 Semester

Because of the COVID-19 pandemic, this course, which is normally taught in-person on the College Ave campus, will be conducted remotely, through a combination of synchronous class meetings using Zoom, and asynchronous discussions, assignments, and quizzes using Canvas. The standard weekly meeting on Zoom will take place at the same starting time that the original course was scheduled for, at 6:10 p.m. ET on Tuesday evenings, but most weeks we will be meeting for only half of the scheduled time, or about 90 minutes. This will be supplemented by increased use of asynchronous Canvas discussion forums and weekly assignments, and optional but recommended individual meetings with the instructor in Zoom Office Hours. Quizzes will be timed and open-book, and conducted in Canvas.

We will aim to make the experience of this course as close as possible to the in-person class, and the weekly Zoom meetings will be a combination of (1) the instructor discussing highlights of the weekly lectures and other important course topics, and (2) participation by everyone in discussions and other activities, often using break-out rooms for smaller-group interaction. After a short non-recorded section of the class each week for open discussion, the lectures and activities will be recorded and posted in Canvas each week for later review.

This new structure is an experiment, and I will be asking for your help and feedback in improving the course throughout the semester, so you can expect some changes, but I will keep the course as straightforward and stable as possible. I understand that we are all living through difficult times, and I strongly encourage you to contact me at any time about any problems related to COVID or otherwise. Together we will be able to make this work for everyone. If you anticipate any technology issues with accessing and using Zoom or Canvas, contact me immediately so we can take care of any issues.

Overview

History has often been presented as the story of how powerful people have changed human societies over the course of time, with presidents, generals, and the wealthy playing central roles. This course will turn the standard approach on its head and instead look at America and the changes it has undergone through the eyes of working people.

What was life like for machine operators, office workers, sharecroppers, housewives, coal miners, immigrants, teachers, and retail workers during the period of American industrial dominance, and how did their actions affect the course of history? This course will tackle these questions, looking at the development of the labor movement and other movements of "ordinary" people and the enormous changes they have wrought in American history. We will not ignore the important roles of the powerful, but we will examine them together with the actions and ideologies of working-class people and their organizations. And we will look at the world surrounding the labor movement and the social and cultural changes in each period.

We will also study the differing forms and ideologies of numerous workers' organizations to understand why some made a real difference and others had little lasting effect. The labor movement has changed dramatically from the early period of industrialization, when the United States was still primarily an agricultural country, through the explosive growth of mass production in the twentieth century. Our approach will highlight the fact that American history has not been a smooth narrative of progress, but rather that change has come about only after struggle over different views of what path the country should take.

Student Requirements

1. *Class participation* (20% of your grade). Your active participation in class is essential for the success of the class. This part of your grade is based on attendance, coming to class on time and prepared by finishing all readings before class, and taking an active part in class discussions and activities. This semester your participation will take place primarily in Zoom.
2. *Online discussion forums and Canvas assignments* (20% of grade). To supplement our class sessions, we will also have discussions and other assignments in Canvas. In the discussion forums you will post responses to questions and to other students' postings by the deadlines listed, basing your comments on class readings and other materials. Often the forum topic will be used as a starting point for in-class discussions in the following class.
3. *Mid-Term Quiz* (15% of grade). The mid-term quiz will consist of essay questions and identification questions (people, events, concepts, etc.), and will be based on lectures, readings, films, and discussions. This semester the quizzes will take place in Canvas, and will be timed and open-book. There may be some changes to the format of the quiz.
4. *Final Quiz* (15% of grade). The final quiz will consist of essay questions and identification questions (people, events, concepts, etc.), and will be based on lectures, readings, films, and discussions, covering the entire course but concentrated on the second half of the semester. This semester the quizzes will take place in Canvas, and will be timed and open-book. There may be some changes to the format of the quiz.
5. *Class paper 1* (15% of grade). For a paper on an assigned topic, you will submit a draft version and later a final version (the draft is required in order to submit a final version). The draft will be reviewed by the instructor.
6. *Class paper 2* (15% of grade). For a paper on an assigned topic, you will submit a draft version and later a final version (the draft is required in order to submit a final version). The draft will be reviewed by another student using a Guided Peer Review.

Note: The general policy on late assignments is that all late assignments will be downgraded one letter grade (e.g. A to B) and will not be accepted more than one week after due date. Contact the instructor immediately if you experience or anticipate any problems and we will make reasonable arrangements as necessary.

The best way to attain a grade you are happy with is to come to class, pay attention, take notes (from lectures and readings), and participate in discussions, both in-class (Zoom) and Canvas!
