Course Description

This course is intended to give students an overview of union organizing strategy and tactics. We will be exploring the contemporary challenges that unions face in their efforts to organize workers, as well as some history of how modern union organizers have arrived at current "best practices." Students will get hands-on practice with some basic organizing tactics – with opportunity for more if desired.

Week 11 – April 5 The Organizing Conversation

This week's class will take the form of a 1-day American Federation of Teachers Organizing Institute training for prospective new organizers. We will be joined by guest lecturers who are seasoned union organizers, as well as workers and job-seekers who wish to explore careers as union organizers. We will engage in a series of role-plays to train, as union organizers train, in "get in the door," "get the story," union vision," "inoculation" and "call the question" techniques that make up "the organizing conversation" that leads to full-scale organizing efforts. Students are invited – although in no way required – to stick around and gain this first-hand experience in the practice of union organizing.
