Resources for Labor Agencies: Supporting Workers' Requests to DHS for Immigration Relief

In January 2023, the Department of Homeland Security announced a new process for labor and employment agencies to support workers by requesting immigration relief from DHS. Since then, government agencies and nonprofits have developed a range of resources on this issue. As more local and state agencies and enforcement officials work to create their own procedures and guidance materials for requesting deferred action and other immigration relief, we have compiled a list of resources—including recently released FAQs from state departments of labor—to support these efforts.
