COURSE DESCRIPTION

To assist in conducting research in the field of labor and employment studies, the course provides an overview of the research strategies and techniques used to determine an information need, to access and evaluate information critically, to incorporate information into one's research, and to use and understand the information effectively and appropriately. Information literacy concepts such as information needs, types and mediums; technological innovations in access to information; evaluation of information; context and documentation; plagiarism, copyright, and intellectual property; censorship and the information industry will be covered.

COURSE OBJECTIVES

At the conclusion of the course, students should be able to:

- 1. Determine the nature and extent of an information need;
- 2. Access needed information effectively and efficiently;
- 3. Evaluate information and its sources critically;
- 4. Use information effectively to accomplish a specific purpose; and
- 5. Understand the ethical, legal and socio-economic issues surrounding the use of information.

WHAT ARE THE LECTURE QUESTIONS?

For each module, you are required to submit two (2) lecture questions. The questions assess how well you understood the lecture material. Each submission of lecture questions in worth 5%.

WHAT ARE THE ACTIVITIES?

For Modules 1, 3 and 6, you are required to complete an activity associated with the themes/concepts from that Module. The activity assess how well you understood the module material. Each activity is worth 10%.

WHAT IS THE NEWS ARTICLE ANALYSIS?

For Modules 2, 4 and 5, you are required to read one news article, and find one news article associated with the themes/concepts from that Module. This assignment assesses how well you can apply the Module themes/concepts to current events in the news.

WHAT IS THE DISCUSSION/PARTICIPATION GRADE?

For every Module, you have the opportunity to either start or continue a discussion/conversation with your classmates. Please feel free to either ask a question you have regarding the Module's content, make a comment on the Module's content, or respond to someone else's question or comment.

LATE ASSIGNMENTS

Assignments over a week late may not be accepted. This is flexible. Please let me know if and when you need extensions.
