### **COURSE DESCRIPTION:**

Professional and college sports have been influenced and altered in all aspects of the game by relationships between the league and the various unions representing the players. Labor unions in the MLB, NFL, NBA, NHL, as well as the WNBA have created the economic and societal landscape that currently dictate modern professional sports. This class will provide a historical basis for understanding the ebbs and flows of salaries, player safety, equity, and competitiveness in professional sprots and how that has influenced amateur sports including the NCAA. The class will also provide in-depth instruction and in class applications of negotiating techniques and strategies in both a collective (union) negotiation and individual (player) negotiations setting.

By fully participating in this class, you will learn the history of collective bargaining in professional sports as well as, negotiating techniques, which may be utilized in any circumstance in life. You will also become aware of the evolution of labor relations in professional sports through the various collective bargaining agreements that are negotiated and how they will impact society.
